## 1. TUITION FEE

• Years 7 and 8	<b>A\$14,080 per semester</b>	<b>A\$28,160 per year</b>

## 3. PAYMENT OF FEES

It is a condition of the visa for a full fee paying overseas student, that tuition (and, if applicable, boarding) fees for each semester are paid prior to the commencement of the semester.

## 4. ANCILLARY CHARGES

An ancillary fee of A\$6,000 per student is charged to cover all ancillary costs for the year. Ancillary costs include:

- Uniform (compulsory) (initial outfitting)
- Textbooks (VCE subjects only)
- Stationery
- Camps and excursions
- Boarding house tutorials
- Boarding house linen
- Other boarding house incidentals
- Victorian School of Language Chinese
- The Victorian Curriculum and Assessment Authority (VCAA) fee
- VCE examination fee
- Flight confirmations
- Airport pick-up - commencement of the school year
- Airport drop-off - end of the school year

The annual ancillary charge **does not** include pocket money, Year 11 Ball (including hire of dress/ suit and shoes), personal expenses or telephone calls.

## 5. HEALTH COVER

All full fee paying overseas students are required by the Australian Government to take out 'Overseas Student Health Cover'.

## 6. USE OF PERSONAL INFORMATION

The information provided by a student to Gippsland Grammar may be made available to Commonwealth and State agencies and the Fund Manager of the Education Services for Overseas Students (ESOS) Assurance Fund pursuant to obligations under the ESOS Act 2000 and the National Code of Practice for Providers of Education to Overseas Students. The School is required to tell the Department about certain changes to the student's enrolment and any breach by the student of a student visa condition relating to attendance or satisfactory academic performance. The overseas student has a duty to advise Gippsland Grammar of any change of address while they are enrolled as a student.
